**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrants today for former inmate Michelangelo Dicosola, 29, of Clinton.

Dicosola, a former inmate who served eight years in several SCDC institutions for armed robbery, is charged with introducing contraband into Tyger River Correctional Institution and trespassing.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
