COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrants today for Steven Gordon Decker, 40, of Laurinburg, N.C.

Decker, who was working as an electrician at Evans Correctional Institution, is charged with providing contraband to inmates, criminal conspiracy and misconduct in office. His charges involve bringing a bag of cell phones inside the institution. He was fired after his arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
