COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrant today for Cierra L. Garner, a correctional officer at Ridgeland Correctional Institution.

Garner, 29, of St. Helena Island, is charged with misconduct in office involving a situation in which an inmate was allowed access to another inmate's cell for the purpose of threats or intimidation. She was suspended in early October once the investigation began, and she was fired today.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
