COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrants todays for two visitors to Kershaw Correctional Institution.

The two are charged with furnishing contraband to a prisoner and criminal conspiracy.

Those charged are:

Lorceecs Frances Cannimore, 49, of Rock Hill Belinda Bonte Brock, 47, of Fort Lawn

Cannimore and Brock are charged with bringing 162 grams of marijuana, 23 cigarettes, 81 grams of tobacco and 40 cigar wraps to an inmate at Kershaw CI on Dec. 21. Cannimore is the inmate's mother and Brock is his common-law wife.

Charges are pending against the inmate.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
