**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrants today for visitors to two institutions recently.

Aja Nicole Montic Drummond, 30, of Roebuck, was arrested Feb. 24 for an incident that occurred at Lee Correctional Institution the day before. She is charged with manufacturing/possession with intent to distribute marijuana, providing contraband to a prisoner and criminal conspiracy. The charges involve 453 grams of marijuana.

Sunayyaha Lakisha Riley Nichols, 38, of Conway, was arrested Feb. 28 for an incident that occurred Jan. 19 at Kershaw Correctional Institution. She is charged with providing contraband to a prisoner and criminal conspiracy. The charges involve 164 grams of tobacco, and charges against an inmate at Kershaw will be forthcoming.

The cases are not related, and both remain open investigations.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
