COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrants today for two visitors to Livesay Correctional Institution last weekend.

Linda Smith, 59, and Tamatha Collins, 47, both from Walhalla, are both charged with:

- Possession with intent to distribute suboxone
- Felony criminal conspiracy
- Providing contraband to a prisoner.

Smith also is charged with possession with intent to distribute methamphetamine. Collins also is charged with possession of a controlled substance.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
