COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrants today for Kashaila Danei Hawthorne, a correctional officer at Perry Correctional Institution.

Hawthorne, 28, of Honea Path, is charged with providing contraband to a prisoner and misconduct in office. Her charges involve providing nude photographs to an inmate on a cell phone and giving him contraband food items. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
