COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrant today for Patrick Nathaniel Carroll, a correctional officer at Broad River Correctional Institution.

Carroll, 36, of Columbia, is charged with simple possession of marijuana. He was fired after his arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
