COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrant today for Tyrone Lamont McCain, a former inmate at several SCDC institutions.

McCain, 32, of Hopkins, was arrested and charged with trespassing. His charges involve entering the property at Lee Correctional Institution to retrieve a drone.

McCain was imprisoned in SCDC three different times beginning in 2006 on a 10-year sentence, which was suspended to four years in prison plus five years probation, for failure to stop for a blue light resulting in death and possessing a stolen vehicle. He was released three times on supervision through the S.C. Department of Probation, Parole and Pardon Services. He violated the terms of the supervision and kept being returned to SCDC complete his sentence. He completed his sentence in 2017.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
