COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today for two civilians arrested outside Livesay Correctional Institution on contraband charges.

Jalen Mailik Lloyd, 24, of Mauldin, and Yorel Ahtrae Hailstock, 24, of Greer, are both charged with possession with intent to distribute suboxone and attempting to furnish contraband to prisoners. Their charges involve 20 suboxone strips found in their possession, along with cell phones and tobacco.

The two were arrested about 1 a.m. today after their car was stopped in front of the institution. The drugs and contraband were found during a search, and a three-year-old child was also in the car at the time. A family member was contacted to care for the child, and the Department of Social Services has been notified.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
