COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today for Brittney Lakeisha Lewis, a correctional officer at Perry Correctional Institution.

Lewis, 27, of Simpsonville, is charged with first-degree sexual misconduct with an inmate and misconduct in office. Her charges involve having a sexual relationship with an inmate. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
