COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today for Shanicka Lequella Stone, a correctional officer at Broad River Correctional Institution.

Stone, 27, of Columbia, is charged with furnishing contraband to a prisoner and misconduct in office. Her charges involve bringing 30 Newport cigarettes into the institution to give to an inmate in return for payment. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
