**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrant today for Patrick Kenneth Maguire, a lieutenant at Tyger River Correctional Institution.

Maguire, 50, of Spartanburg, is charged with misconduct in office. His charges involve disabling a recording device to the video surveillance system in a housing unit at the institution. He was fired after his arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
