**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrants today for Jatuane Malik Huggins, a correctional officer at MacDougall Correctional Institution.

Huggins, 24, of Elloree, is charged with criminal conspiracy and misconduct in office. His charges involve being paid \$1,500 to allow inmates to retrieve contraband cellphones, tobacco and marijuana that had been dropped on the prison yard by drones. He was fired after his arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
