COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today for a North Charleston man on drug charges.

Christopher M. Fultz, 39, is charged with possession of marijuana, methamphetamines and the generic version of Xanax. Information about plans to introduce contraband into an SCDC prison was discovered through intelligence gathering involving Fultz and an SCDC inmate. Agents arrested Fultz at a North Charleston hotel.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

Copies of the arrest warrants are attached.

The department thanks the Charleston County Sheriff's office and the North Charleston Police Department for their assistance in this arrest.
