COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants for two Myrtle Beach men arrested outside MacDougall Correctional Institution yesterday.

Shyquain Rashawn McCray, 24, and Anthony Hakeem Kyrique Chestnut, 21, are both charged with furnishing contraband to a prisoner and criminal conspiracy. During the investigation, SCDC's intelligence unit developed information about plans to smuggle contraband into the prison. McCray and Chestnut were arrested outside the institution attempting to hide tobacco and cellphones in a dumpster on the MacDougall farm.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On June 2, 2021, while at the MacDougall Correctional Institution (MacCI) located at 1516 Old Gilliard Rd. Ridgeville, SC, Berkeley County, Defendant Shyquain Mccray did violate Section 24-3-950 of the South Carolina Code of Laws. Attempt to Furnish a Prisoner with Contraband, to wit: Between May 1, 2021 and June 2, 2021, communication from an inmate at MacCI was intercepted, via the recorded inmate phone system, where the inmate and individuals conspired to introduce contraband into MacCI. On June 2, 2021, Mccray and a Co-Defendant traveled to MacCI where they trespassed onto SCDC property and attempted to hide tobacco and cell phones in a dumpster on the MacCI Farm. SCDC Office of Investigations and Intelligence (OII) Agents were waiting and detained Mccray and his Co-Defendant.
