COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrant for a Spartanburg man on contraband charges involving an inmate at Camille Graham Correctional Institution.

Donald Thomas Page Jr., 45, was arrested and charged with conspiracy to introduce contraband into a prison. The charges against Page involve working with an inmate to smuggle suboxone strips, methamphetamine and tobacco into the Columbia women's prison in April.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
