**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrants today for three people arrested outside Kershaw Correctional Institution yesterday.

Kobrandum Kshawn Bostick, 29, and Kimar Lezon Bostick, 38, both of Estill, and Krystal Pinkeny, 34, of Springfield, Ga., are all charged with attempting to provide contraband to a prisoner. The three were arrested during a traffic stop near the institution. Officers found a drone and three duct taped packages containing tobacco, cellphones and rolling papers during the arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

SCDC thanks the Lancaster County Sheriff's Department for its assistance in this case.
