**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrant today for a correctional officer at Wateree River Correctional Institution.

Kaylee Alyssa Showler, 27, of Rembert, is charged with first degree sexual misconduct with an inmate. Her charges involve having sexual intercourse with an inmate at the prison between January and July 2021. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

Showler, employed by the State of South Carolina Department of Corrections (SCDC), did commit the offense of Sexual Misconduct with an Inmate 1st Degree to wit: The defendant did have sexual intercourse with state inmate [REDACTED] at the Wateree Correctional Institution (WrCI). The victim has been housed at WrCI since 9/19/2019 and remains in custody. The defendant was hired by SCDC on 01/11/2021. Probable cause is based on audio and written statement of the defendant post Miranda. This incident did occur at WrCI, located at 8200 State Farm Road, Rembert, Sumter County, SC.
