**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrant today for a correctional officer at Wateree River Correctional Institution.

Kaylee Alyssa Showler, 27, of Rembert, is charged with first degree sexual misconduct with an inmate. Her charges involve having sexual intercourse with an inmate at the prison between January and July 2021. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
