COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today for a Summerville woman on charges involving introducing contraband into Ridgeland Correctional Institution.

Shelene Jean Walk, 25, was arrested and charged with attempting to introduce contraband into the prison, possession of marijuana with intent to distribute and criminal conspiracy. Her charges involve selling 70 grams of a substance that field tested to be marijuana to an undercover officer with the intent of dropping the drugs onto the Ridgeland yard with a drone.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
