**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrants today for two Upstate men involved in introducing contraband into Livesay Correctional Institution.

Matthew Keith Holcombe, 20, of Pelzer, and Dakota Joe Wyatt, 23, of Liberty, were arrested in a vehicle in the parking lot of Livesay CI Jan. 22. Both are charged with furnishing or attempting to furnish contraband to a prisoner and criminal conspiracy. Holcombe also is charged with contraband from an incident on Jan. 15.

The charges against Holcombe and Wyatt, both of whom are former inmates, involve six pounds of tobacco, unopened bottles of vodka, rolling papers, cigarettes and tins of smokeless tobacco.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
