I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

That on February 26, 2022, at the Palmetto Express, 1440 Wisacky Hwy., Bishopville, SC in the county of Lee, one Martell Lee Johnson did furnish or attempt to furnish contraband to a prisoner at Lee Correctional Institution. An anonymous tip was received that the defendant was to be dropped out of a white vehicle at the Palmetto Express. He would be carrying a black book bag and walk to Lee Correctional Institution to introduce contraband into the facility by use of a drone. Agents located the defendant matching the description given by the anonymous tip. Upon contact with the defendant, agents did locate a yellow drone and six duct taped wrapped packages containing tobacco. Affiant has evidence to prove same.

An anonymous tip was received that the defendant, Martell Johnson, was to be dropped out of a white vehicle at the Palmetto Express and would be carrying a book bag. He would walk to LCI to introduce contraband into the facility by using a drone. Agents located the defendant matching the description given in the anonymous tip. The defendant did have a yellow drone and six duct taped wrapped packages containing tobacco.
