I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On September 29, 2021, Special Agent James Perry obtained evidence that was extracted from the cell phone of Napieria Brihm, a sworn Certified Correctional Officer with the SCDC. Cellphone contained several screenshot conversations with inmate [REDACTED] who is currently housed at Kershaw County Correctional Institution (KerCI). [REDACTED] was previously housed at Trenton Correctional Institution (TrCI) located at 84 State Highway S-19-29 in the County of Edgefield, SC. while Brihm was employed there. Numerous tags on the extraction consisted of images showing C/O Brihm sending nude photographs to [REDACTED] several screenshots of Cash App deposits, weapons, gang related hand signs, contraband and C/O Brihm using her personal phone while on duty in an SCDC vehicle. Probable cause is based on Police investigation.
