**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrants today for a Cheraw woman on charges involving contraband at Camille Graham Correctional Institution.

Suzanne Leigh McCauley, 38, is charged with providing contraband to a prisoner and criminal conspiracy. Her charges involve mailing a letter to an inmate that contained Suboxone. McCauley is a former SCDC inmate who has been imprisoned three times since 2012 for drug and property crimes. She most recently was released in 2020.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
