COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrant today for a Summerville man on theft charges at Ridgeland Correctional Institution.

Robby Willie Tracy, 36, is charged with larceny. His charge involves the theft of an SCDC cellphone during inmate visitation on March 10.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
