**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrants today for a correctional officer at Trenton Correctional Institution.

Colette Antionette Dunbar, 31, of Aiken, is charged with possession of marijuana with intent to distribute, providing contraband to a prisoner, criminal conspiracy and misconduct in office. The charges against her involve bringing about 260 grams of a substance that field tested positive as marijuana into the institution. She will be fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
