COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrant today for an additional charge against a Licensed Practical Nurse who previously worked at Livesay Correctional Institution.

New charges were filed today against Shimano Cheek-Mcfadden for first-degree sexual misconduct with an inmate. Cheek-Mcfadden, 32, of Spartanburg, was charged last month with providing contraband to an inmate. She was fired after the first charges were filed.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
