**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrants today for a correctional officer at Camille Graham Correctional Institution.

Khalim Jovan Battle, 31, of Gastonia, N.C., was arrested and charged with two counts of first-degree sexual misconduct with an inmate and two counts of misconduct in office. The charges involve sexual encounters with two inmates. He was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
