**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrant today for a former correctional officer at Broad River Correctional Institution.

Andrea Michelle Green, 41, of Columbia, was arrested and charged with forgery. The charge involves submitting fraudulent documents to SCDC placing her on active duty with the N.C. Army National Guard in February 2021. She resigned before the investigation was completed.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on February 12, 2021, the Defendant, Andrea Michelle Green, did commit the offense of Forgery/Forgery 16-13-0010(A) to wit: on February 12, 2021, the Defendant, Andrea Michelle Green, submitted fraudulent Department of Defense military orders to the South Carolina Department of Corrections Division of the Human Resources office at the Broad River Correctional Institution, located at 4446 Broad River Road, Columbia, SC, 29210, in Richland County. The orders placed her into Active Duty Status with the North Carolina Army National Guard, granting her leave from her employed position as a Correctional Officer, and payments from SCD, totaling \$4,433.10. The document was provided to authorities within the Department of Defense, and their investigation into the validity of the document found it to be fraudulent.
