COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrant today for a former correctional officer at Wateree River Correctional Institution.

Sarah Eileen Brady, 44, of Columbia, was arrested and charged with misconduct in office. The charge involves communicating with an inmate who was using an illegal cellphone. She resigned before the investigation was complete.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
