COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrant today for a former correctional officer at Wateree River Correctional Institution.

Sarah Eileen Brady, 44, of Columbia, was arrested and charged with misconduct in office. The charge involves communicating with an inmate who was using an illegal cellphone. She resigned before the investigation was complete.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On June 26, 2021, in the County of Sumter, the defendant, Sarah Brady, a sworn officer with the South Carolina Department of Corrections (SCDC) did commit the offense of Misconduct / Misconduct in Office to wit: The defendant did willfully, dishonestly, and with corrupt intent, engage in, misconduct in the form of malfeasance, misfeasance, or nonfeasance, by committing acts in violation of her duty of good faith, honesty, and accountability of public trust as a State Correctional Officer, by communicating with inmate [REDACTED] a lawfully incarcerated inmate incarcerated at the Wateree Correctional Institution (WrcI) located at 8200 State Farm Rd, Rembert, SC 29128, via social media. Cellphone extradition information retrieved from a contraband cellphone show CO Brady wearing lingerie and showing her breast. Messages between the two suggest they have kissed, and that oral sex was performed.
