COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrant today for a former inmate on charges involving contraband at Kershaw Correctional Institution.

Yah'Quann Jonte Gantt, 28, of Columbia, is charged with providing contraband to a prisoner. His charge involves positioning a drone carrying contraband outside Kershaw CI. During the arrest, the drone, which was being operated remotely, took off and flew to the prison.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
