**COLUMBIA, S.C.** – The SCDC Inspector General released arrest warrants today for a correctional officer at Tyger River Correctional Institution.

William Bradley James Sigafoos, 26, of Spartanburg, is charged with providing prisoners with contraband, criminal conspiracy and misconduct in office. The charges involve providing tobacco and cellphones to a prisoner at Tyger River.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
