**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for a woman suspected of smuggling contraband into McCormick Correctional Institution during visitation.

Marion N. Sackel, 54, of Aiken, is charged with providing contraband to a prisoner and criminal conspiracy. Her charges involve giving an inmate a package containing two cellphones during visitation Nov. 5.

In addition to the criminal charges, Sackel's visitation privileges are permanently revoked.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
