**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for three men on contraband charges involving inmates at McCormick Correctional Institution.

Those charged are:

- Brian Francis Williams Jr., 31, of Richland County
  - Trafficking in methamphetamines more than 100 grams.
  - Trafficking in crack/cocaine more than 100 grams.
  - Possession of marijuana with intent to distribute.
  - Criminal conspiracy.
  - Providing contraband to prisoners.
- Allen Jerome Benton, 43, of Hampton County
  - Providing contraband to prisoners.
  - Criminal conspiracy.
- Donte Calloway, 31, of Colleton County
  - Providing contraband to prisoners.
  - Criminal conspiracy.

The charges involve dropping a package containing meth, crack/cocaine, marijuana and other contraband by drone into McCormick CI. Copies of the arrest warrants are attached.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
