COLUMBIA, S.C. – The SCDC Inspector General released arrest warrants today for a correctional officer at Manning Reentry/Work Release Center.

Shanelle Betterson Eichelberger, 35, of Richland County, is charged with first-degree sexual misconduct with an inmate and misconduct in office. The charges involve a sexual encounter Dec. 21, 2022. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On or about 12/21/2022 while at 502 Beckman Rd at Manning Correctional Institution (MRMRC), in Richland County, one Shanelle Betterson Eichelberger, a certified officer with the SC Department of Corrections (SCDC) did commit the crime of Misconduct in Office, Statute Number 17-25-0030. It is believed the defendant committed the crime because she did willfully, knowingly and with corrupt intent, engage in misconduct in the form of malfeasance, misfeasance, or nonfeasance by committing acts in violation of her duty of good faith, honesty, and accountability of public trust as a State Correctional Officer, by engaging in sexual intercourse with inmate [REDACTED]. Probable cause is based upon video evidence documenting the sexual encounter. The def did admit under Miranda she was the female in the video engaging in sexual intercourse. Inmate [REDACTED] did admit he was the male in the video engaging in sexual intercourse with the defendant & recording.

That on or about 12/21/2022 while at 502 Beckman Rd at Manning Correctional Institution (MRMRC), in the Upper Township Magisterial District of Richland County, one Shanelle Betterson Eichelberger did commit the crime of Sexual Misconduct With An Inmate-1st Degree, Statute Number 42-23-1150(C)(1). It is believed the defendant committed the crime because she did have sexual intercourse with inmate [REDACTED]. Probable cause is based on cell phone recovery which contains video evidence documenting the sexual encounter. Shanelle Betterson Eichelberger admitted under Miranda that she was the female in the video engaging in sexual intercourse. Inmate [REDACTED] admitted that he was the male in the video engaging in sexual intercourse and recording. Affiant and others are witness to prove same. Case# 34-2022-124.
