COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for two Berkeley County men on contraband charges involving inmates at Lee Correctional Institution.

Christopher M. Meredith, 44, and John Charles Carrington, 31, are both charged with:

- Distribution of methamphetamines.
- Criminal conspiracy.
- Providing contraband to a prisoner.

The charges involve four pounds of tobacco attached to a drone near Lee CI. Officers also confiscated 1.8 grams of a substance that tested positive for meth.

Meredith is a former inmate who has served four different stints in SCDC, mostly on drug charges.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

Copies of the arrest warrants are attached.

SCDC's Inspector General thanks the Lee County Sheriff's office and the S.C. Department of Natural Resources, as well as the SCDC Division of Security, for assistance in this case.
