COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a Summerville man on contraband charges involving inmates at Lee Correctional Institution.

Joshua B. Jordan, 31, is charged with furnishing contraband to a prisoner. Jordan's charges involve attempting to fly a drone carrying contraband tobacco onto the prison yard.

At the time of his arrest, Jordan was out on bond for two previous incidents:

- Trafficking cocaine, providing contraband to prisoners and other <u>charges involving</u> <u>drone drops at Lieber Correctional Institution</u> in February 2022. He was released on \$25,000 bond.
- Arson second degree charge that involves <u>setting fire to the home of a contraband</u> <u>officer</u> at Lieber in March 2022. He was released on \$200,000 bond.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

A copy of the most recent arrest warrant and mug shot is attached.
