**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for a Myrtle Beach man on contraband charges involving inmates at Lieber Correctional Institution.

Akilo Kenyon Turner, 35, is charged with furnishing contraband to a prisoner and criminal conspiracy. Turner's charges involve driving two men from Conway to Ridgeville and accompanying them as they flew a drone carrying drugs, rolling papers, tobacco, a scale and lighter onto the prison yard.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
