COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a visitor to Tyger River Correctional Institution.

Jennifer Rose Lazurick, 33, of Spartanburg, is charged with trafficking methamphetamines, drug conspiracy and furnishing prisoners with contraband.

Lazurick's charges involve bringing a substance that field tested positive for meth into the prison during weekend inmate visitation.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
