COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for two women in unrelated cases involving attempts to bring drugs to prisoners during Sunday visitation at Lee Correctional Institution.

- Stacie Garrett White, 34, of Atlanta, is charged with possession of marijuana with intent to distribute, providing contraband to a prisoner and resisting arrest. Her charges involve 77 grams of a substance that tested positive for marijuana concealed in clear plastic and tape inside her body.
- Misha Cortory Gore, 37, of Columbia, is charged with possession of methamphetamines with intent to distribute, providing contraband to a prisoner and criminal conspiracy. Her charges involve 31 grams of a white rock-like substance that tested positive for meth concealed in a condom inside her body.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
