COLUMBIA, S.C. – The SCDC Inspector General released arrest warrants today for a correctional officer in training at Turbeville Correctional Institution.

Shauntee Lynette Brumfield, 44, of Sumter, is charged with providing prisoners with contraband and criminal conspiracy. Her charges involve bringing a cellphone, tobacco, a digital scale and chargers into the institution. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
