COLUMBIA, S.C. – Inmate Richard Alexander Murdaugh has been convicted of two internal disciplinary charges – Abuse of Privileges and Unauthorized Use of an Inmate’s PIN Number. He had a disciplinary hearing for these charges on Aug. 28, and he lost his telephone and canteen privileges for 30 days.

The charges involve providing information to be delivered to the news media for an interview and also using a fellow inmate’s PIN number to make a telephone call. These charges violate SCDC’s inmate interview policy and our policy against inmates sharing PIN numbers. They are not a violation of law.


Murdaugh provided the interview information to his attorney through a legal call. Legal calls are not recorded or monitored on the inmate phone system per attorney/client privilege. Attorney Jim Griffin recorded Murdaugh reading the information and provided it to the media.

When information reached the department on Aug. 8 about the interview, Murdaugh’s tablet and phone privileges were immediately revoked, pending a review of the incidents. After his phone privileges were revoked, Murdaugh used a fellow inmate’s PIN number to make a telephone call, which is prohibited by our [policy OP-22.14](#).

The department has sent a letter to Murdaugh’s attorneys explaining that their conduct is prohibited by policy and warning the attorneys of the consequences.

Inmates in the custody of the S.C. Department of Corrections are not allowed to do interviews. SCDC’s interview policy is rooted in victims’ rights and is longstanding. The department believes that victims of crime should not have to see or hear the person who victimized them or their family member on the news. Inmates lose the privilege of speaking to the news media when they enter SCDC.

Tablets are designed and secured for correctional use. They are considered a privilege. The department will determine when and if inmate Murdaugh will earn the opportunity to be issued a tablet again.

Dear Mr. Griffin:

As you are probably aware, your client was recently convicted of an internal disciplinary infraction related to your June 10, 2023, telephone conversation with him where Mr. Murdaugh was reading excerpts from a journal he maintained during the Colleton County trial. In our Inspector General's interview of Mr. Murdaugh, he indicated that you recorded those journal entries and provided them to the media. Inmates in the custody of the S.C. Department of Corrections are not allowed to participate in interviews of this nature.

Your actions, whether you intended or not, assisted Mr. Murdaugh in violating our policy and could jeopardize your telephonic communications with him in the future. Attorney calls are provided to assist with legal claims, not for other unrelated purposes. I am hopeful that this letter will put you on notice and caution you to refrain from further actions of this nature.

Thank you for your attention to this matter. Please do not hesitate to contact me or our General Counsel should you have any questions or need further clarification.
