COLUMBIA, S.C. – The S.C. Law Enforcement Division and the SCDC Office of Inspector General are investigating a sexual assault that occurred this afternoon at McCormick Correctional Institution.

Charges are pending against 23-year-old inmate Timothy Darren Sherard Jr. He is being moved to another institution tonight.

The employee who was assaulted is being treated at a local hospital. The attack did not happen in a living area but in another part of the prison.

Charges will be released when the arrest warrants are served. No further information is available tonight.
