COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrant today for a nursing supervisor at Broad River Correctional Institution.

Deandra Raileen Frierson, 29, of Winnsboro, is charged with providing prisoners with contraband. Her charge involves bringing a cellphone to an inmate. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
