COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a former inmate on contraband charges involving a package of contraband at Goodman Correctional Institution.

Justin Tyshad Chisolm, 32, of Charleston, is charged with attempting to provide prisoners with contraband, criminal conspiracy, trespassing and resisting arrest. He is accused of collaborating with inmates at Goodman and Lieber correctional institutions to introduce the contraband at Goodman.

Chisolm was spotted trespassing on SCDC property off Broad River Road and ran from authorities. SCDC's drone team helped locate Chisolm in the woods near the institution.

Chisolm served two previous stints in SCDC as a youthful offender.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

Copies of the arrest warrants are attached.

SCDC thanks the Columbia Police and Richland County Sheriff's departments and S.C. Department of Juvenile Justice authorities for their partnership and help in this arrest.
