**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for a Myrtle Beach man on charges involving contraband at Wateree River Correctional Institution.

Nasidd Zavion Vereen, 22, is charged with trafficking methamphetamines more than 400 grams, providing prisoners with contraband, possession of marijuana with intent to distribute, possession of narcotics and criminal conspiracy.

Vereen is accused of entering the property at Wateree River and throwing two duffel bags filled with contraband over a fence. The duffel bags were filled with contraband, including meth, marijuana, Oxycodone, vape pens, cellphones, vodka, lighters, knives, tobacco and other contraband items.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
