COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a Summerville man on contraband charges involving a drone at Lieber Correctional Institution.

Damien Rakari Anderson, 25, is charged with providing prisoners with contraband, possession of marijuana with intent to distribute and criminal conspiracy.

Officers confiscated a drone, marijuana, tobacco, cellphones, a knife and other contraband items during the arrest, which occurred on a road near the institution.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

Copies of the arrest warrants are attached.
