COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a former inmate on charges involving drones at Broad River Correctional Institution.

Quintin Alexander Douglas, 28, of Bethune, is charged with four counts of criminal conspiracy. His charges involve flying drones carrying contraband into Broad River CI in April and July 2023.

At the time of his arrest, Douglas was <u>out on bond from charges</u> of flying drones carrying contraband into McCormick Correctional Institution in 2023.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
